# HOURS OF OPERATION

Our childcare center operates from Monday to Friday, from 6:00 AM to 6:00 PM. We understand the demands of modern-day schedules, and we strive to accommodate the needs of working parents by providing extended hours.

## UNSCHEDULED CLOSINGS/INCLEMENT WEATHER

In the event of unscheduled closures due to inclement weather or unforeseen circumstances, parents will be notified promptly via email, text message, or phone call. The safety and well-being of our children and staff are our top priorities.

# **TUITION AND FEE POLICY**

At Journeys of the Heart Inc., tuition is due in advance at the weekly rate. Payments are expected on Monday morning for the upcoming week of childcare services. Your payment will be considered late if not received by Tuesday after 5:30 PM.

Late payments will incur a late payment fee of \$40.00 per week. Parents may pay by check or money order. Please note that tuition remains the same whether your child is in attendance for one day or the entire week.

During holidays, tuition is still due to reserve your child's placement in our program.

Additionally, we enforce a late pickup fee if you are unable to pick up your child by 6:00 PM. You will be charged \$1.00 per child for every minute until your child(ren) are picked up.

We appreciate your adherence to these policies, as they help us maintain the quality and consistency of our childcare services. If you have any questions or concerns regarding tuition or payment procedures, please feel free to contact us.

# WATER ACTIVITIES

At Journeys of the Heart Inc., we offer various water activities for children to enjoy during the summer break. We understand the importance of safety and cleanliness when it comes to water play.

Parents are required to give permission for their children to participate in water activities, and appropriate swimwear must be worn at all times. This permission is indicated on our admission form. During water table play, we ensure that the water tables and toys used are emptied, sanitized, and washed daily after each use. Children and caregivers are required to wash their hands before and after using the water tables to maintain hygiene standards.

Sprinkler play is held within our designated playground area on the grass. We store sprinklers and water hoses out of children's reach when not in use to prevent accidents.

Our priority is to provide a safe and enjoyable environment for all children to engage in water activities. If you have any concerns or questions regarding our water activities policy, please feel free to contact us.

### Admission and Enrollment

At Journeys of the Heart Inc., we are committed to providing a nurturing and inclusive environment for all children, regardless of race, color, sex, creed, religion, national or ethnic origin, provided that our established program meets the needs of the individual child with reasonable accommodations (in accordance with the Americans with Disabilities Act - ADA).

Enrollment at Journeys of the Heart Inc. is subject to availability and completion of required paperwork, including enrollment forms, health records, and emergency contact information. We welcome children of all backgrounds and abilities.

We believe in celebrating the diversity of our community and strive to create a culture of respect, acceptance, and understanding. Our staff is trained to accommodate the unique needs of each child, ensuring that every child feels valued, included, and supported in their learning and development.

# **UN-ENROLLING YOUR CHILD(REN)**

At Journeys of the Heart Inc., we understand that circumstances may arise requiring families to un-enroll their child from our childcare program. In order to facilitate a smooth transition and make necessary arrangements, we require written notice at least two weeks in advance if you need to un-enroll your child.

When un-enrolling your child(ren), please provide a written notice to the administration at least two weeks before the intended withdrawal date. This allows us adequate time to adjust our staffing and resources accordingly and ensures minimal disruption for your child.

It's important to note that Journeys of the Heart School Age reserves the right to immediately un-enroll any child under certain circumstances. Un-enrollment may occur if a child poses a threat to themselves or others, or if they consistently refuse to follow center policies despite interventions and support. We strive to maintain a safe and supportive environment for all children in our care, and we appreciate your cooperation in adhering to our un-enrollment policy. # TRANSPORTATION

At Journeys of the Heart Inc, we understand the importance of providing safe transportation for children to and from school. Therefore, we offer transportation services exclusively for children attending our daycare from their respective schools.

Our transportation policy adheres to strict safety guidelines to ensure the well-being of all children in our care during transit. Parents must provide written consent for their child to be transported by Journeys of the Heart Inc staff.

Our trained and licensed drivers operate our daycare vehicles, equipped with appropriate safety features and maintained to the highest standards. We strictly adhere to all traffic laws and regulations during transportation.

Upon arrival at the daycare, children are supervised by our qualified staff members until they are safely handed over to their designated guardians.

### Licensing

### **Developmental Milestones**

At Journeys of the Heart Inc., we prioritize the holistic development of each child in our care. Milestone assessments are conducted regularly, and progress reports are shared with parents to keep them informed about their child's development.

#### Toddlers (12-24 Months)

Therefore, our program encourages and supports these large muscle activities as legitimate expressions of toddlerhood.

#### Preschool (2-5 Years)

Preschoolers are typically most responsive to activities that allow them to be actively involved in a hands-on manner. Our teachers embrace this understanding and design classroom spaces with various learning centers where children can freely choose to participate and explore at their own pace. Our dedicated staff regularly rotate and add materials to these learning centers to maintain and extend children's interests.

In instances where commercial materials may not fully meet the needs or interests of the children, our teachers are adept at creating their own games and materials tailored to the children's unique preferences and developmental stages. We believe that young children learn best when engaged in activities that build upon their interests and abilities.

Open-ended questioning and activities are integral to our approach, fostering the development of creative thinking skills in children. Information and discoveries about

each child's developmental progress are shared collaboratively between teachers and parents, resulting in a tailored program that meets the individual needs of every child.

# Holidays

- Martin Luther King Jr. Day
- July 4th Holiday
- Thanksgiving Day & Friday
- Christmas Day

Please note that when a holiday falls on a Saturday, we will be closed on the preceding Friday, and when a holiday falls on a Sunday, we will be closed on the following Monday.

It's important to understand that tuition fees are not reduced for holidays listed above. This policy ensures consistency in our operations and staffing, allowing us to maintain the quality of care and education for your child throughout the year.

### Caregivers

### Television

### Activity Plans and Supervision

For children who choose to work on homework assignments, our caregivers provide dedicated study time, offering support and guidance as needed.

### Smoking/Drugs/Alcohol Policy

At Journeys of the Heart Inc., the safety and well-being of the children in our care are our top priorities. To ensure a secure environment for all, we ask that all adults adhere to the following guidelines:

- A. If an adult's behavior and/or health status pose an immediate threat or danger to the health and safety of the children, they must not be present when children are in our care. This includes situations where an adult's behavior may compromise the safety of the children or if they are experiencing symptoms of illness that could be contagious.
- B. We strictly prohibit the consumption of alcohol or controlled substances on the premises of Journeys of the Heart Inc. Additionally, smoking or the use of tobacco products is not allowed anywhere on our premises. This policy applies to all staff, visitors, and parents/guardians.

We maintain a zero-tolerance approach to behaviors that may jeopardize the safety of the children or violate our policies regarding substance use. Any violations of these policies will be addressed promptly and may result in removal from the premises or termination of employment, as appropriate.

### Parent Open Door and Participation Policy

Parents are welcome to visit their child(ren) in our center, including during program activities, and explore the building and premises. ## **Release of Children**

Ensuring the safety and security of every child in our care is of utmost importance at Journeys of the Heart Inc. To maintain a secure environment, we have implemented strict procedures for releasing children to authorized individuals.

Children will only be released to individuals listed as authorized pick-up persons on their enrollment forms. It is imperative that these authorized individuals are accurately listed on the admission form provided upon enrollment.

For verification purposes, photo identification may be required from any individual seeking to pick up a child. This measure helps us confirm the identity of the authorized person and ensures the safety of the child.

On the admission form, there is a designated space indicating the individuals authorized to pick up the child. It is crucial that this information is kept up to date and accurately reflects the current list of authorized persons.

### Immunization Requirements for Caregivers

At Journeys of the Heart Inc., the health and safety of our children, families, and staff members are paramount. Therefore, we uphold stringent guidelines regarding staff immunizations to prevent the spread of communicable diseases in our childcare facility.

All staff members are required to provide proof of immunization or immunity to certain communicable diseases as mandated by state/country regulations. This requirement aligns with our commitment to maintaining a healthy environment for everyone in our care.

Currently, Journeys of the Heart Inc. does not mandate that caregivers receive vaccinations. However, we recognize the importance of staying informed about updates and recommendations from authoritative health agencies such as the Department of Family and Protective Services (DFPS) and the Centers for Disease Control and Prevention (CDC).

In the event that DFPS or CDC mandates vaccination for caregivers, we will require all staff members to comply with the specified vaccine requirements. This includes receiving each specified vaccine that the caregiver is not exempt from having, unless medical conditions are identified as contraindications or reasons of conscience, including religious beliefs.

We are committed to ensuring that our childcare facility remains a safe and healthy environment for all. ## Vision and Hearing Screening

At Journeys of the Heart Inc., we prioritize the overall health and well-being of the children in our care, including their vision and hearing health. To ensure early detection of any potential issues, we may conduct periodic vision and hearing screenings.

These screenings are conducted in accordance with Texas state licensing requirements and are typically recommended for children aged four and older. It is mandated by Texas state licensing that every four-year-old have proof of vision and hearing screening, with documentation placed in the child's file.

Parents will be notified of the results of these screenings, and if any issues are identified, recommendations for follow-up care will be provided. We encourage parents to schedule vision and hearing screenings with their child's physician, as these screenings can also be performed during regular check-ups.
